On March 27, 2012 at approximately 1544 hours, I responded to the residence located at 317 S 9<sup>th</sup> Ave in reference to a possible burglary. The home owner was standing outside the residence and unsure if anyone was inside the residence.

While responding to this location I contacted Ptl Smith over the patrol radio and asked that he also respond to this location. Upon our arrival Ptl Smith and I made contact with Blanco Molinaro (homeowner). I asked Molinaro to wait outside while we assured know one was currently still inside the residence. We cleared the inside of the residence and did not locate anyone inside at this time.

Molinaro stated that she knew that someone had been inside the residence because some of her belongings were all over the bed. I then checked all the doors and windows inside the residence to find them secure. Molinaro then stated that the screen to her back screened in porch had been cut. I then walked to the northeast side of the residence and observed a large cut in the screen leading into the porch area. In the dirt area just below the window I observed what appeared to be a partial show print. Photos were taken of the shoe prints. I walked the back and side dirt areas of the yard and was unable to locate anymore shoe prints.

I then returned back inside the residence. While looking at the doors that lead to the porch area it was noticed that the curtain was closed in the door. Molinaro stated that she would not do that. After opening the door it was observed that something had recently pried the door. The metal piece that closes into the latch had new pry marks on the metal. At this time it was determined that this was the point of entrance and exit to the residence. Ptl Smith attempted to lift prints from the door with no success.

I then asked that Molinaro come into her bedroom (southeast corner) and advise what areas appeared to be disturbed. Molinaro stated that her jewelry box that had been on top of the dresser located at on the north was missing. Molinaro later found the box inside the top drawer but the jewelry inside was missing. Molinaro stated that there had been three pairs of 18kt gold hoop earrings in the box. Molinaro stated that two of the pairs of earrings were just plain large hoops and one pair was square. Molinaro also stated that an 18kt gold necklace with attached butterfly charm, an 18kt gold necklace with gold round charm with solid black center and another 18kt gold necklace was also missing. Molinaro then stated that her Italian passport that was in the east side night stand was missing. Molinaro then stated that an older unknown make, model and serial number laptop had been taking from her son's bedroom (southwest corner). The laptop had been on top of the desk on the west wall of the room. Molinaro stated that she could not think of anything else that appeared to be missing at this time.

After Molinaro advised of the missing property, Ptl Smith dusted the top portion of the dresser located on the east wall. I then was able to lift a couple different partial prints from the area. Ptl

Smith then dusted the top of the night stand on the east side of the bed. I was again able to lift a couple different partial prints. Ptl Smith dusted the dresser on the north wall however; I was unable to lift any prints from this area. Ptl Smith also dusted two wooden jewelry boxes that had been moved. No prints were found on either box. The prints along with photos were submitted into evidence at the Wauchula Police Department.

I asked Molinaro what time she had last been at her residence. Molinaro stated that she had left her residence at approximately 0500 hours this morning headed to Tampa with an employee, Sara. Molinaro stated that she and Sara returned to her residence at approximately 1100 hours, Molinaro stated that she did not notice anything at this time. Molinaro stated that she then went to work at Giovanni's until 1530 hours when she returned home. Molinaro stated that she walked into her residence and noticed her belongings lying on the bed and walked back outside. Molinaro stated that her husband, Giovanni left the residence to go to the restaurant at approximately 0500 hours this morning and did not return until she called him about this incident. Molinaro stated that her son, Jose left the residence headed to school in Clearwater at approximately 0500 hours this morning and has not been back. Molinaro stated that Jose was currently at Giovanni's working.

I then asked Molinaro if they would suspect anyone. Molinaro stated that she could not think of anyone. I asked Molinaro if there were any employees that they had recently fired or she thought would be involved. Molinaro stated that they had not recently fired anyone and she did not believe any of their current employees would do this.

At this time I provided Molinaro with a victim's right brochure with my name and case number. I advised Molinaro if she had any questions or concerns to contact the police department. I also advised Molinaro that if she located anything else that appeared to be missing or if she located the make, model or serial number for the laptop to contact the police department.

A neighborhood canvass was then conducted of the area. No one was currently home at the residences located at 318 and 319 S 9<sup>th</sup> Ave. Contact was made with Theresa Alexy at 320 S 9<sup>th</sup> Ave. Alexy stated that she had been at the hospital all day and had not seen anything. She was advised if she noticed anything suspicious in the area to contact the police department.

After clearing this location I responded to Giovanni's and made contact with Jose Molinaro. Jose stated that he had left the residence this morning at 0530 hours to go to school in Clearwater. Jose stated that he drove straight back to Wauchula to work. Jose stated that he had not been back to the residence since he left this morning. I then asked Jose if there would be anyone he would think who could be involved. Jose stated that he did not know of anyone. I then asked Jose if he would consider any of the employees. Jose stated that he did not feel like any of the employees would do that. Jose stated that different employees have been over to the residence to help with mowing the yard, planting flowers and dropping off restaurant supplies with no problems in the past.

At this time this case is open pending further investigation. Contact was made with Det Sgt Brock who advised that he would make contact with the jewelry stores and pawn shops tomorrow (3/28/2012).

#### FOLLOW UP

On March 31, 2012, I conducted a follow up investigation in reference to the burglary that had occurred on Tuesday, March 27, 2012 at 317 S 9<sup>th</sup> Ave.

I made contact with the victim, Blanca Molinaro. Molinaro stated that on March 28, 2012 while she was at home she noticed two male subjects around her house acting suspicious. Molinaro stated that the two subjects just kept walking back and forth down the street. Molinaro stated that when the subjects saw her one of the subjects pulled out a measuring tape and measured the sidewalk. Molinaro stated that the two then left headed west towards Florida Ave.

Molinaro described one subject as a Hispanic male between the age of 18-21. She stated that he was approximately 5'04 and very skinny. She stated that he had darker skin. She stated that he had long (shaggy) black hair. She stated that he was wearing black pants and black shirt.

Molinaro described the second subject as a Hispanic male between the age of 18-21. She stated that he was approximately 5'04 and very skinny. She stated that he had lighter skin. She stated that he had short light brown hair. She stated that he was wearing jeans and two shirts.

I advised Molinaro if she observed the subjects again to contact the police department.
