JG: DEPUTY GOINS

JS: UH, DEPUTY GOINS IS THE PERSON BEING INTERVIEWED. IF YOU WOULD RAISE YOUR RIGHT HAND FOR ME, DO YOU SWEAR AND AFFIRM THE STATEMENT YOU'RE ABOUT TO MAKE WILL BE THE TRUTH, THE WHOLE TRUTH AND NOTHING BUT THE TRUTH?

JG: YES SIR

JS: OK, WHEN YOU WENT TO THE CRASH THE OTHER NIGHT, THAT VICTORIA AND MICHAEL LAKE

JG: UH HUH

JS: WAS INVOLVED IN, UH, DID YOU SEE, SMELL, OR SEE ANYTHING OR SMELL ANYTHING THAT WOULD LEAD YOU TO BELIEVE THAT EITHER ONE OF THEM WAS UNDER THE, UNDER THE INFLUENCE OF ALCOHOL?

JG: NO SIR

JS: DID YOU TALK TO EITHER ONE OF THEM?

JG: NO SIR

JS: OK, UH, DID ANYBODY INDICATE TO YOU, WHO WAS THE
DRIVER OF THE VEHICLE WAS?

JG: NO SIR

JS: OK, UH, DID YOU EVER GO OVER BY THE CAR WHEN THEY
CLEANED IT OUT?

JG: NO SIR, THERE WAS WIRES DOWN, SO I DIDN'T GO

JG: YES SIR

JS: IS THERE ANY, YOU KNOW, UM, IS THERE ANYTHING ELSE THAT

OF THAT VEHICLE WAS UNDER THE INFLUENCE OF ALCOHOL
THAT YOU RECOGNIZED?
